July 22, 2010

A regular meeting of the City Council of Vinton, Iowa, was held on the 22nd day of July, 2010, at 7:00 p.m., in the City Hall Council Chambers, Vinton, Iowa. Mayor ProTem Burkey presided and the roll being called the following Council Members were present and absent: Present: Burkey, Elwick, Hessenius, Maynard. Absent: Redlinger, Vermedahl.

Motion by Elwick, second by Hessenius to approve the minutes of the July 8th and July 13th meetings. Question: Ayes - All. The Mayor ProTem declared the motion carried.

Motion by Maynard, second by Hessenius to approve the agenda. Question: Ayes - All. The Mayor ProTem declared the motion carried.

Mark Christy, 803 E 10th Street, asked Council to consider placing stop signs on 10th Street at the intersection of 9th Avenue. The traffic is fast and there are kids playing in the neighborhood. Many neighbors are also in favor of placing stop signs here. The Public Safety Committee will meet on August 12th at 6:30 to consider this subject.

The Mayor ProTem declared the motion carried and declared RESOLUTION 07-10-05 passed and approved. The bid is awarded to Abatement Specialties for \$51,432.00.

Motion by Hessenius, second by Elwick to pass a RESOLUTION TO APPROVE AGREEMENT WITH IOWA DEPARTMENT OF TRANSPORTATION FOR AIP GRANT TO REHABILITATE AIRPORT RUNWAY 16-34 AND OBJECT FREE AREA GRADING. Motion by Maynard, second by Hessenius to approve a request from JJAM Promotions for a supervised display of fireworks at the Benton County Fairgrounds, conducted by Chuck Yedlik, on July 25th. Question: Ayes - All. The Mayor ProTem declared the motion carried.

Motion by Elwick, second by Hessenius to approve Attorney Fischer attending the Speer Financial golf outing on August 5th. Question: Ayes - All. The Mayor ProTem declared the motion carried.

Motion by Hessenius, second by Elwick to receive and file the minutes of the Parks and Rec. Board meeting of July 8, 2010. Question: Ayes - All. The Mayor ProTem declared the motion carried.

Coordinator Lent reported on: 1) Lent to schedule a meeting of the Public Works Committee and the school board next month to discuss water drainage. 2) AmeriCorps has done some surveying for a CDBG application.
