REGULAR COUNCIL MEETING November 10, 2010

A regular meeting of the City Council of Vinton, Iowa, was held on the 10th day of November, 2010, at 7:00 p.m., in the City Hall Council Chambers, Vinton, Iowa. Mayor Watson presided and the roll being called the following Council Members were present and absent: Present: Burkey, Elwick, Hessenius, Maynard, Redlinger, Vermedahl. Absent: None.

The Pledge of Allegiance was recited.

Motion by Elwick, second by Vermedahl to approve the minutes of the October 28th meeting. Question: Ayes - All. The Mayor declared the motion carried.

Motion by Burkey, second by Redlinger to approve the following invoices in the amount of \$538,541.16, excluding investments and a duplicate entry for fuel in the sewer department. Question: Ayes - All. The Mayor declared the motion carried.

Motion by Vermedahl, second by Redlinger to approve the agenda. Question: Ayes - All. The Mayor declared the motion carried.

Motion by Burkey, second by Hessenius to pass a RESOLUTION DIRECTING THE DISPOSAL OF AN INTEREST IN REAL PROPERTY FOLLOWING A PUBLIC HEARING. Question: Ayes - Burkey, Elwick, Hessenius, Maynard, Redlinger, Vermedahl. Nays - None. The Mayor declared the motion carried and declared RESOLUTION 11-10-01 passed and approved. The property is sold to Jeff & Kelly Pohlmann for \$5,002 plus costs.

Motion by Burkey, second by Elwick to pass a RESOLUTION TO APPROVE AMENDING ENGINEERING SERVICE AGREEMENT FOR WEST 10TH STREET PROJECT. Question: Ayes - Burkey, Elwick, Hessenius, Maynard, Redlinger, Vermedahl. Nays - None. The Mayor declared the motion carried and declared RESOLUTION 11-10-02 passed and approved.

Council discussed the alley between properties owned by Jason Cox on W 5th Street. Cox would like to purchase this vacated alley. Janet Sanders, owner of property on W 6th Street, would like to keep this alley open for access to the back side of her property. There is an east-west alley from E Avenue that also gives access to this property. Motion by Hessenius, second by Elwick to proceed with selling this vacated alley to Jason Cox. Pat Lyons, Ideal Industries representative, requested permission for a controlled burn of old wood on the north side of their property. The fire department may help this burn. Motion by Maynard, second by Elwick to approve this request. Question: Ayes - All. The Mayor declared the motion carried. The wind direction will be considered before starting the burn.

Motion by Vermedahl, second by Hessenius to approve a new native wine permit with Sunday sales for Henkle Creek. Question: Ayes - All. The Mayor declared the motion carried.

Motion by Vermedahl, second by Hessenius to approve a new class c liquor license with Sunday sales for High 5 Sports Bar & Grill. Question: Ayes - All. The Mayor declared the motion carried.

Motion by Vermedahl, second by Hessenius to approve Sunday sales privilege for a native wine permit for L Marie Boutique. Question: Ayes - All. The Mayor declared the motion carried.

Motion by Burkey, second by Redlinger to receive and file the October revenue and expenditure report. Question: Ayes - All. The Mayor declared the motion carried.
