A regular meeting of the City Council of Vinton, Iowa, was held on the 23rd day of January, 2014, at 7:00 p.m., in the City Hall Council Chambers, Vinton, Iowa. Mayor Watson presided and the roll being called the following Council Members were present and absent: Present: Elwick, Hessenius, Maynard, Stark. Absent: Bendull, Redlinger.

The Pledge of Allegiance was recited.

Motion by Hessenius, second by Stark to approve the minutes of the January 9th meeting. Question: Ayes - All. The Mayor declared the motion carried.

The Mayor reported that a budget work session for fiscal year 2014-2015 was held Jan. 13th.
